

Privacy Policy

Your privacy is critically important to us.

It is NG Logic's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to nglogic.com (hereinafter, "us", "we", or "nglogic.com"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

Website Visitors

Like most website operators, NG Logic collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. NG Logic's purpose in collecting non-personally identifying information is to better understand how NG Logic's visitors use its website. From time to time, NG Logic may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

NG Logic also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on <http://nglogic.com> blog posts. NG Logic only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

Gathering of Personally-Identifying Information

Certain visitors to NG Logic's websites choose to interact with NG Logic in ways that require NG Logic to gather personally-identifying information. The amount and type of information that NG Logic gathers depends on the nature of the interaction. For example, we ask visitors who sign up for a blog at <http://nglogic.com> to provide a username and email address.

Security

While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

Advertisements

Ads appearing on our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by NG Logic and does not cover the use of cookies by any advertisers.

Nglogic.com uses Google AdWords for remarketing

Nglogic.com uses the remarketing services to advertise on third party websites (including Google) to previous visitors to our site. Aggregated Statistics

NG Logic may collect statistics about the behavior of visitors to its website. NG Logic may display this information publicly or provide it to others. However, NG Logic does not disclose your personally-identifying information.

Cookies

To enrich and perfect your online experience, NG Logic uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. NG Logic uses cookies to help NG Logic identify and track visitors, their usage of <http://nglogic.com>, and their website access preferences. NG Logic visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using NG Logic's websites, with the drawback that certain features of NG Logic's websites may not function properly without the aid of cookies.
